# **Course Description:**

Fundamental principles of soil science, including the origin, nature, and classification of soils, emphasizing the chemical, physical and biological properties in relation to growth and nutrition of plants.

# **Course Objectives:**

- 1. Identify the Five Key Functions of Soil in our ecosystem.
- 2. Describe how indigenous people, including Tohono O'odham, evaluate soils.
- 3. Describe the factors influencing the formation of soils.
- 4. Recognize the distribution and use of the 12 soil orders.
- 5. Relate the influence of the 7 soil physical properties to the functions of soils.
- 6. Apply soil-water functions to soil management.
- 7. Associate soil aeration and soil temperature with the soil environment.
- 8. Recognize the nature and properties of colloidal soil properties.
- 9. Determine the influence of soil reaction, pH, on soil management decisions.
- 10. Identify the properties of alkaline and salt affected soils of arid regions.
- 11. Recognize the importance of soil organisms and organic matter in soil ecology.
- 12. List the macro-nutrient and micro-nutrient elements of soils.
- 13. Recognize the goals of practical nutrient management.
- 14. Associate the significance of soil erosion with land degradation.
- 15. Recognize how soils can affect plant communities and plant growth.
- 16. Apply data found in the Soil Survey of the Tohono O'odham Nation to the practical use of soil science principles.

## Workload:

Students are expected to spend an average of 15 hours per week attending class sessions, doing assignments and research, reading and preparing for exams. The standard Carnegie Unit of college credit assigns one credit hour for each 15 hours of class time throughout the semester and assumes that students spend two hours working outside the classroom for each hour of classroom instruction. For a four-credit course that includes a lab, this translates to 225 hours per semester or an average of fifteen hours per week for a 15 or 16-week semester.

## Incomplete (I) grade:

To receive an "I" grade, you must have finished at least 1/2 of the course requirements and specifically request the grade. Please call before the last week of class to be sure that there is sufficient time to consider your request. An incomplete grade generally implies that a student has shown sufficient initiative to complete the course on his or her own. You will receive a copy of the standard "I" form filed with the grade. This form details specifically what must be done to complete the course. A student has one semester (4 months) to complete the required work, after which the grade automatically reverts to an "F."

# Special Withdrawal (Y) grade:

The "Y" grade is an administrative withdrawal given at the instructor's option when no other grade is deemed appropriate. Your instructor must file a form stating the specific rationale for awarding this grade. "Y" grades are discouraged since they often affect students negatively. Your instructor will not award a "Y" grade without a strong reason. Any student missing 4 consecutive class meetings without prior approval may be withdrawn by the instructor.

# Make-up Exams:

• There can be one makeup exam **only** with prior approval by the instructor. Any missed exam without approval will receive zero points for that exam.

**Final Grades:** Students will receive a grade transcript from the college mailed to the address given with registration materials at the end of the semester when all grades have been recorded. Students who wish to check grades may call 520-383-8401.

**SPECIAL NOTE TO STUDENT:** For privacy and security reasons, instructors are advised **NOT** to give grades over the telephone.

- Your instructor will make every attempt to follow the above procedures and schedules, but they may be changed in the event of extenuating circumstances.

#### Attendance:

- When you do not attend class, it is your responsibility to make up what you have missed.

- Students must attend a minimum of 20 class sessions to receive a grade or an incomplete. It is the responsibility of the student to withdraw from the class if he or she has excessive absences, or decides to discontinue the class.
